## Ordinance No. 2013-<u>01</u>

## AN ORDINANCE OF THE CITY OF TROY, ILLINOIS, PROVIDING FOR THE INSTALLATION OF A STOP SIGN AT A CERTAIN LOCATION IN THE CITY OF TROY, ILLINOIS

WHEREAS, upon order of the City Council of the City of Troy, Illinois, the Chief of Police has conducted a traffic study of a certain intersection located within the corporate limits of the City of Troy, Madison County, Illinois, and submitted a recommendation to the Law Enforcement and Emergency Services Committee; and

**WHEREAS**, the Law Enforcement and Emergency Services Committee has approved the recommendation of the Chief of Police and recommended to the City Council the installation of the stop sign at the location set forth in the traffic study prepared by the Chief of Police; and

WHEREAS, the City Council of the City of Troy, Illinois has determined that the public safety will be promoted by establishing a stop sign at the location set forth by the Chief of Police;

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS AS FOLLOWS:

<u>Section 1.</u> That the City Council hereby determine that the preambles Hereto are true and correct and are incorporated herein by reference as if fully set forth at this point.

<u>Section 2.</u> A stop sign is hereby required and shall be installed as follows:

(a) Eastbound Crossington Lane at the intersection with Fairington Drive

<u>Section 3.</u> A stop sign conforming to the Illinois Department of Transportation's Sign Manual and Specifications shall be erected at the intersection described in Section 2 above, such intersection being within the City of Troy, Illinois. The location of this sign shall conform to the requirements of the Illinois Department of Transportation's Sign Manual and Specifications.

<u>Section 4.</u> Any person who disobeys the stop signs to be placed pursuant to this Ordinance shall be guilty of the offense of failing to obey a traffic control device, and shall be fined not less than \$25.00 and more than \$500.00 for each such offense.

<u>Section 5.</u> The Code of Ordinances of the City of Troy, Illinois, Chapter 73, Schedule VI, is hereby amended to reflect the above described stop sign placement.

<u>Section 6.</u> If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.

<u>Section 7.</u> The high volume of traffic and concerns for safety make it urgent that this Ordinance be effective immediately upon adoption pursuant to section 1-2-4 of the Illinois Municipal Code. This Ordinance has been approved by two thirds of the Corporate Authorities now holding office. It shall be published in pamphlet form.

<u>Section 8.</u> This Ordinance shall be in full force and affect from and after its passage and approval and publication in pamphlet, according to the law.
