## Ordinance No. 2014-05A

An Ordinance Establishing a “No Parking Zone” on the East and West side of Border Street from Illinois Route 162 North to Clay Street in the City of Troy, Madison County, Illinois

---

**WHEREAS**, the City of Troy, Madison County, Illinois has heretofore established certain “No Parking Zone” to promote pedestrian and vehicular safety on the streets thoroughfares of the City of Troy; and

**WHEREAS**, based on a study conducted by the Troy Police Department, the City has determined that the establishment of a “no parking zone” will further enhance pedestrian and vehicular safety within the corporate limits of the City of Troy;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS AS FOLLOWS:**

Section 1. That the City Council hereby determine that the preambles hereto are true and correct and are incorporated herein by reference as if fully set forth at this point.

Section 2. That section 14-69 of the Code of Ordinance of the City of Troy is hereby amended by establishing a No Parking Zone on the East and West side of Border Street from Illinois Route 162 North to Clay Street in the City of Troy, Madison County, Illinois.

Section 3. No Parking signs conforming to the Illinois Department of Transportation’s Sign Manual and Specification shall be erected at the no parking zones describes in Section 2 above. The location of these signs shall conform to the same requirements of the Illinois Department of Transportation’s Sign Manual and Specifications.

Section 4. If any section of provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provision of this Ordinance, which can be given effect without the invalid section or provision, and to this end, the sections and provision of this ordinance are declared to be severable.

Section 5. The high volume of traffic and concerns for safety make it urgent that this Ordinance be effective immediately upon adoption pursuant to section 1-2-4 of the Illinois Municipal Code. This Ordinance has been approved by two-thirds of the Corporate Authorities now holding office.

Section 6. This Ordinance shall be in full force and affect from and after its passage and approval and publication in pamphlet, according to the law.
