# Ordinance No. 2014 -

AN ORDINANCE Annexing and Zoning Certain Territory To and in the City of Troy, Madison County, Illinois (Namely, 2011 Formosa Road Owned by the Wilfred I Meier and Rose T. Meier Trusts)

WHEREAS, Wilfred I Meier Trust and Rose T. Meier Trust, owners of certain territory also known as 2011 Formosa Road, Troy, Illinois which is not within the corporate limits of any municipality, but which is contiguous to the City of Troy, Illinois, and Hotel Ventures Management of Illinois, Inc., petitioner, have filed a written petition with the City of Troy requesting that said territory be annexed to the City of Troy, Illinois, a copy of which is attached hereto as Exhibit C; and

WHEREAS, the property owner has represented that there are no electors residing on the property; and

Survey Required Date 6 /18/14 **WHEREAS**, a legal description of the territory to be annexed is attached hereto as Exhibit A and the map attached hereto, marked Exhibit B, is an accurate map of said territory so sought to be annexed;

**WHEREAS**, in compliance with the laws of the State of Illinois providing therefore, notice was given to the Trustees of the Troy Fire Protection District; the Supervisor, Trustees, and Highway Commissioner of Jarvis Township; and the Trustees of the Tri-Township Public Library in the manner provided by Statute, and all required notices have heretofore been given as required by law concerning the petition for annexation of this territory to the City of Troy;

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the statutes of the State of Illinois, specifically, 65 ILCS, para 5/7-1-8.

Now, Therefore, Be It Ordained By The Mayor And The City Council Of The City Of Troy, Madison County, AND ILLINOIS As Follows:

SECTION 1: That the following territory also known as 2011 Formosa Road, Troy, Illinois is hereby annexed and made a part of the City of Troy, Illinois, in accordance with the petition duly filed with the City of Troy, Illinois

<u>SECTION 2</u>: That the described territory of land is hereby established in the zoning classification of "R-1 Low Density Residential." Said classification shall apply to the territory described as it has been established and is classified for zoning in the City of Troy, Madison County, Illinois.

SECTION 3: That the map attached hereto marked Exhibit B, and made a part hereof, which is found to be an accurate map of the annexed territory, shall be filed of record with this Ordinance.

SECTION 4: That the City Clerk is hereby directed to record with the Recorder of Deeds and to file with the County Clerk a certified copy of this Ordinance, together with copies of the annexation notice, the affidavit of service of notices, and the exhibits appended to this Ordinance.

<u>SECTION 5</u>: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

<u>SECTION 6</u>: This Ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.


