AN ORDINANCE OF THE CITY OF TROY, ILLINOIS, PROVIDING FOR THE JURISDICTIONAL TRANSFER OF SOUTH MAIN STREET (FAU 9393) TO THE MUNICIPAL STREET SYSTEM OF THE CITY OF TROY, ILLINOIS

WHEREAS, it is the best interest of the health, safety and welfare of the citizens of the City of Troy to have safe street surfaces to travel upon in the City; and

WHEREAS, the City of Troy and the State of Illinois have mutually determined that the transfer of South Main Street (FAU 9393) is necessary to keep the street surface in the safest condition; and

WHEREAS, the City of Troy and the State of Illinois have entered into an agreement for transfer of jurisdiction South Main Street (FAU 9393) to the Municipal Street System of the City of Troy.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS AS FOLLOWS:

- <u>Section 1.</u> That South Main Street (FAU 9393) from the South Edge of Pavement of West Market Street/IL Route 162 (FAP 586A) southerly 0.78 mile to the North Edge of Pavement of US Route 40 (FAP 793), in its entirety, be added to the Municipal Street System of the City of Troy.
- <u>Section 2.</u> That the City Council of the City of Troy approves the adoption of "Addendum 4" of the Local Agency Jurisdictional and its supporting materials, as hereby attached, as part of this Ordinance.
- <u>Section 3.</u> If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.
- <u>Section 4.</u> This Ordinance shall be in full force and affect from and after its passage and approval and publication in pamphlet, according to the law.
- <u>Section 4.</u> The City Clerk will forward a certified copy of this Ordinance to the State of Illinois through its District Engineer's Office in Collinsville, Illinois.
