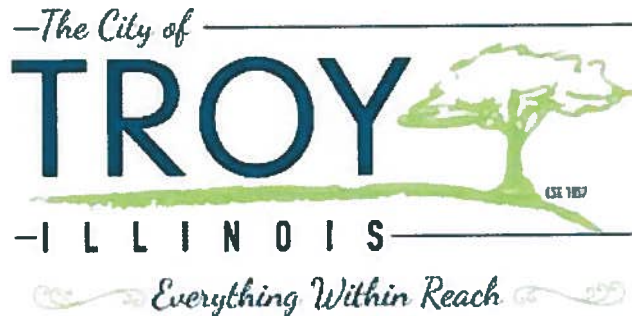

Ordinance No. 2015-23

AN ORDINANCE OF THE CITY OF TROY, ILLINOIS, DECLARING CERTAIN VEHICLES TO BE SURPLUS AND AUTHORIZING BID OF THE SAME

WHEREAS, the City of Troy is the owner of certain motor vehicles, which more particularly described below; and

WHEREAS, the auction bid through Municipal Bid Online Government Auctions of such vehicles is in the best interests of the City of Troy, Illinois

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS AS FOLLOWS:

Section 1. That as declared by the vote of a simple majority of the aldermen of the City of Troy, the following motor vehicles are declared to be surplus property, and shall be auctioned pursuant to 65 ILCS 5/11-76-4.

2004 Mazda 3S (VIN Number JM1BK123441161533); and
2005 Dodge Ram 2500 Quad (VIN Number 3D7KS28C95G709046).

Section 2. The following terms of AUCTION shall apply:

a. The vehicles shall be advertised for auction.

Section 3. The City Administrator shall make a recommendation for acceptance or rejection of this bid at a regular City Council Meeting.

Section 4. This Ordinance shall be in full force and affect from and after its passage and approval and publication in pamphlet, according to the law.
