ORDINANCE NO. 2016 - 18

AN ORDINANCE AMENDING CHAPTER 72, SECTION 23 AND CHAPTER 74, SCHEDULE II, OF THE CODE OF ORDINANCES FOR THE CITY OF TROY, ILLINOIS, TO REMOVE PARKING RESTRICTIONS ON THE NORTH AND SOUTH SIDES OF MEADOW DRIVE

WHEREAS, the City of Troy, Illinois, has heretofore established certain no parking zones and parking restrictions to promote pedestrian and vehicular safety on the streets and thoroughfares of the City of Troy; and

WHEREAS, based on a recent review conducted by the City of Troy, Illinois, the City has determined that the removal of certain parking restrictions, and the corresponding creation of additional parking spaces, will further enhance pedestrian and vehicular safety within the corporate limits of the City of Troy; and

WHEREAS, the City of Troy believes it is in the best interests of the City and its citizens to remove the parking restrictions on Meadow Drive as follows:

Parking restrictions to be removed:

Meadow Drive – North Side at the following addresses:

425 Meadow Drive
429 Meadow Drive
431 Meadow Drive
435 Meadow Drive
439 Meadow Drive

Meadow Drive – On its North Side:

From a point beginning 400 feet east of the intersection with Wren Hill to Mockingbird Lane.

Meadow Drive – On its South Side:

From a point beginning at Riggin Road to a point 200 feet west of the intersection with Mockingbird Lane

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. That the City Council hereby determines that the preambles hereto are true and correct and are incorporated herein by reference as if fully set forth herein.

Section 2. The City shall remove all "No Parking" signs at these locations and replace them with parking signs conforming to the Illinois Department of Transportation's Sign Manual and Specifications. The location of these signs shall conform to the same requirements of the Illinois Department of Transportation's Sign Manual and Specifications.

Section 3. If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.

Section 4. This Ordinance shall be effective upon its passage, signing and publication as required by law.
