AN ORDINANCE AMENDING TITLE I, GENERAL PROVISIONS, CHAPTER 10 – RULES OF CONSTRUCTION; GENERAL PENALTY - OF THE CODE OF ORDINANCES, TO INCLUDE SECTION 10.98 – POLICE DEPARTMENT FEES AND CHARGES

WHEREAS, the Mayor and the City Council of the City of Troy, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the City Council of the City of Troy, Illinois, has reviewed the provisions of the current text of Chapter 10 of the Code of Ordinances and determined that it requires certain amendments to conform with current legal standards and operational practices; and

WHEREAS, the City Council of the City of Troy, Illinois, has reviewed the charges and fees set forth in the proposed amendment, and believe that they are both reasonable and necessary in relation to the services being provided; and

WHEREAS, the City Council of the City of Troy, Illinois, believes it is beneficial and necessary to protect the safety, health and welfare of the citizens and the peace of the City of Troy, Illinois, to amend Chapter 10 of the Code of Ordinances accordingly.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. The recitals set forth above are hereby incorporated herein as if fully set forth.

Section 2. Section 10.98 – POLICE DEPARTMENT FEES AND CHARGES– is hereby added to Title I, General Provisions, Chapter 10 – Rules of Construction; General Penalty - of the Code of Ordinances for the City of Troy, Illinois, as follows:

TITLE I. Rules of Construction; General Penalty

Chapter 10 – General Regulations

Section 10.98. POLICE DEPARTMENT FEES AND CHARGES

The following is a list of applicable fees and charges for services performed by the Troy Police Department:

Records Check	\$10.00
Fingerprints	\$20.00
Dog Release	\$20.00
Tow Release (Ord. 2011-22)	\$200.00
False Alarms	\$25.00
Sex Offender (Initial Registration/Renewal)(730 ILCS 150/3(c)(6))	\$100.00
OVT (Ord. 2012-08)	\$50.00
Bail Processing Fee	\$20.00

Section 3: That all other provisions of Chapter 10 of the Code of Ordinances shall remain unchanged and in full force and effect except as specifically amended by this Ordinance.

Section 4: If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.

Section 5: This Ordinance shall be effective upon its passage, signing and publication as required by law.
