ORDINANCE NO. 2017 - 05

AN ORDINANCE AUTHORIZING THE PURCHASE OF LAND BY THE CITY OF TROY, ILLINOIS

WHEREAS, 65 ILCS 5/11-61-3 *et seq.* authorizes the City of Troy, Illinois, to acquire real property for public purposes; and

WHEREAS, the City Council of the City of Troy, Illinois, believe that it is in the best interest of the City to acquire land from Victoria Lynn Fischer for the sum of Forty Thousand Dollars (\$40,000.00), to allow for Bike Trail access north of the Spring Valley Road intersection, upon the terms and conditions as set forth in the Purchase Agreement attached hereto and incorporated herewith.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals are true and accurate and are hereby incorporated by reference.
2. The Mayor and Clerk of the City of Troy, Illinois, are hereby authorized to execute the Purchase Agreement attached hereto as "Exhibit A" providing for purchase of land from Victoria Lynn Fischer for the sum of Forty Thousand Dollars (\$40,000.00), upon the terms and conditions as set forth in said Agreement.
3. The Mayor and/or City Administrator of the City of Troy, Illinois, are hereby authorized to execute and deliver any deeds, closing statements, or other documents necessary to complete this transaction and the City Clerk is authorized to attest to the same.
4. If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.
5. This Ordinance shall be effective upon its passage, signing and publication as required _____ by _____ law.



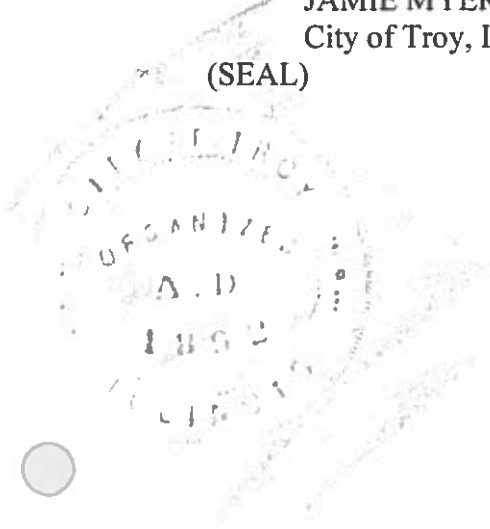
