**ORDINANCE NO. 04**

**AN ORDINANCE DECLARING CERTAIN PERSONAL PROPERTY OWNED  
BY THE CITY OF TROY, ILLINOIS, AS SURPLUS AND AUTHORIZING SALE  
(GENERATOR)**

**WHEREAS**, it has been determined by the corporate authorities of the City of Troy, Illinois, that there exists certain surplus property that is owned by the City and controlled by the Public Works Department – a Generator (Specifications -Exhibit A-Attached)

**WHEREAS**, the City of Troy, Illinois, is expressly authorized by the Illinois Municipal Code, 65 ILCS 5/11-76-4, to sell or convert any surplus personal property that is no longer necessary or useful to the City;

**WHEREAS**, the corporate authorities of the City of Troy, Illinois, find and determine that the best interests of the City of Troy, Illinois, and its residents will be served by declaring said property surplus, and authorizing the sale of said property to the highest bidder.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF  
THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:**


1. The recital above is true and accurate and is hereby incorporated by reference.
2. The City of Troy, Illinois, reserves the right to accept and/or reject any and/or all bids.
3. The Mayor and/or City Administrator of the City of Troy, Illinois, are hereby further authorized to execute and deliver any other documents necessary and/or required of the City in furtherance of any such sale, and Clerk of the City of Troy, Illinois, is further hereby authorized to attest to same.
4. If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.
5. This Ordinance shall be effective upon its passage, signing and publication as required by law.
