## **ORDINANCE NO. 2020-25**

- **WHERAS,** the City of Troy is the owner of certain motor vehicles and/or equipment, which more particularly described below; and
- WHERAS, the auction bid through Govdeals Online Government Auctions of such vehicles and/or equipment is in the best interest of the City of Troy, Illinois
- NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS AS FOLLOWS:
- <u>Section 1.</u> That as declared by the vote of a simple majority of the alderman of the City of Troy, the following motor vehicles and/or equipment are declared to be surplus property, and shall be auctioned pursuant to 65 ILCS 5/11-76-4.

- Section 2. The following terms of AUCTION shall apply:

- <u>Section 3.</u> The City Administrator shall make a recommendation for acceptance or rejection of this bid at a regular City Council Meeting.

<u>Section 4.</u> This Ordinance shall be in full force and affect from and after its passage and approval and publication in pamphlet, according to the law.
