### ORDINANCE NO. 2021 - 05

## AN ORDINANCE OF THE CITY OF TROY, ILLINOIS AMENDING ORDINANCE 2010-10 AND REVISING SEWER FEE

WHEREAS, the Mayor and City Council of the City of Troy, Madison County, Illinois, find that it is in the best interest of the City and the citizens of Troy and for the public health, safety, and welfare to periodically review and analyze the various fees, services charges, and rates associated with municipal services: and.

WHEREAS, the costs and expenses of providing municipal services have increased substantially and will continue to increase annually due to increases in the cost of labor, materials, equipment, fuel and supplies. Exhibit A reflects an annual increase in sewer fees through 2027.

WHEREAS, the corporate authorities find that the increase in the number of users of municipal services has resulted in an increase in the manpower necessary to meet the demand; and,

WHEREAS, the corporate authorities believe it is in the best interest of the City and its citizens and for the public health, safety, and welfare that the City fees, service charges, and rates be modified to reflect the increase in the cost of operating and maintaining the municipal infrastructure; and,

## NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The recitals set forth above are true and correct and incorporated herein.
- 2. The fees, service charges and rates charged by the City of Troy listed in Exhibit "A", attached hereto and incorporated herein, are hereby approved and adopted by the City of Troy.
- 3. This Ordinance shall be effective upon its passage, signing and publication as required by law. It may be published in pamphlet form.
