ORDINANCE NO. 2021- 11

AN ORDINANCE OF THE CITY OF TROY AUTHORIZING THE CITY TO ENTER INTO AND THE MAYOR TO EXECUTE AN EMPLOYMENT AGREEMENT BETWEEN THE CITY OF TROY AND JAY KEEVAN

WHEREAS, the Mayor and the City Council of the City of Troy, Illinois, desire to enter into an Employment Agreement to employ Jay Keevan (“Employee”) as the City Administrator for the City of Troy, Illinois (“Employer”); and

WHEREAS, the Mayor and the City Council of the City of Troy, Illinois, believe it is in the best interest of the City to enter into an Employment Agreement between the Employer and Employee to set forth the terms and conditions of Employee as the as the City Administrator for the City of Troy, Illinois.

NOW, THEREFORE, be it ordained by the Mayor and the City Council of the City of Troy, Madison County, Illinois, as follows:

SECTION 1. The recitals set forth above are incorporated herein and are true and accurate.

SECTION 2. The Employment Agreement between the Employer and Employee, a copy of which is attached hereto as Exhibit "A", is hereby approved and adopted.

SECTION 3. The Mayor, on behalf of the City of Troy, Illinois, is hereby authorized to execute, and the City Clerk is directed to attest, the Employment Agreement between the Employer and Employee.

SECTION 4. This Ordinance shall be in full force and effect after its passage and approval as provided by law.

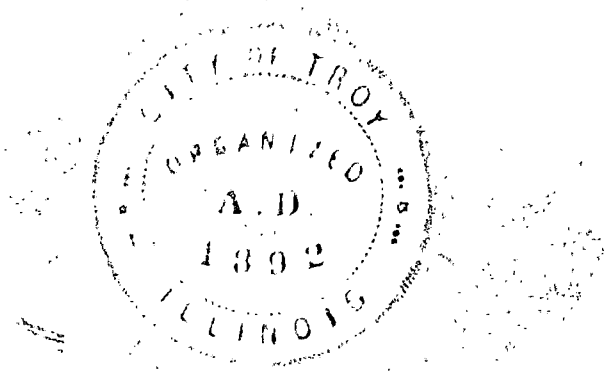
