WHEREAS, the Mayor and the City Council of the City of Troy, Illinois, believe it is necessary and in the best interests of the health, safety and welfare of its citizens to adopt and post general park rules for all City parks within the City of Troy, Illinois; and

WHEREAS, the City has prepared and recommends the adoption and posting of the general park rules attached hereto for all City parks within the City of Troy, Illinois.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TROY, COUNTY OF MADISON, STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1. The preambles set forth above are hereby deemed true and accurate and are incorporated herein.

SECTION 2. The City of Troy, Illinois, hereby adopts the general park rules for all City parks within the City of Troy, Illinois, a copy of which is attached hereto and incorporated herein.

SECTION 3. The City of Troy, Illinois, also hereby authorizes the posting of the general park rules for all City parks within the City of Troy, Illinois, at each respective City park within the City of Troy, Illinois.

SECTION 4. This Resolution shall be in full force and effect after its passage and approval as provided by law.



General Park Rules for City of Troy Parks

Bud Klaustermeier Park, Donald Spencer Memorial Park, Paul Simon Memorial Park

- 1. Park Hours: Dawn until Dusk**
- 2. Speed limit: 15 mph**
- 3. No glass bottles or containers**
- 4. All pets must be on a leash at all times**
- 5. Solicitation or sale of items is prohibited**
- 6. No firearms allowed**
- 7. No open fires allowed**
- 8. No fireworks allowed**
- 9. Drinking is prohibited without a Liquor Permit**
- 10. No personal trash dumping**
- 11. No unauthorized off-road vehicles allowed**
- 12. No camping without authorization**
- 13. Any destruction of Park property will be prosecuted**
