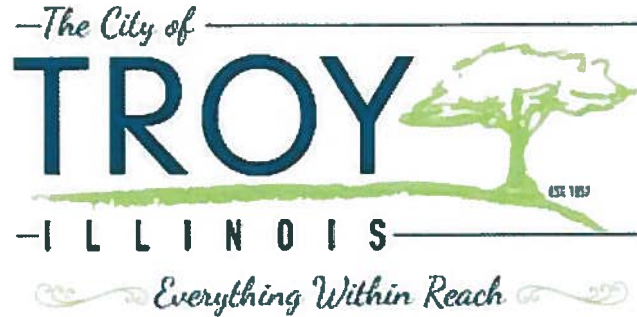

**RESOLUTION NO. 2016 -09**

**A RESOLUTION OF THE CITY OF TROY, ILLINOIS  
AUTHORIZING THE CITY TO APPLY FOR GRANTS**

**WHEREAS**, the City of Troy, Illinois is applying to the Metro East Park and Recreation District, for Fiscal Year 2016 Park and Trail Grant Matching Program; and

**WHEREAS**, it is necessary that an application be made and agreements entered into with the Metro East Park and Recreation District.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TROY, ILLINOIS, AS FOLLOWS:**

**Section 1.** The City of Troy apply for FY 16 Park and Trail Grant Matching Program under the terms and conditions of the Metro East Park and Recreation District and shall enter into and agree to the understandings and assurances in said applications.

**Section 2.** The proposed project description be identified as Spring Valley Road Shared-Use Path-Phase 1.

**Section 3.** The Mayor and City Administrator, on behalf of the City of Troy, Illinois, execute such documents and all other documents necessary for the carrying out of said application.

**Section 4.** The City of Troy will contribute \$126,906.50 in local match and will be reimbursed by Metro East Park and Recreation District in the amount of \$42,301.00 at final closeout of project.

**Section 5.** The Mayor and City Administrator are authorized to provide such additional information as may be required to accomplish the obtaining of such grant.

**Section 6.** This Resolution shall be in full force and effect after its passage and approval as provided by law.

**PASSED** by the City Council of the City of Troy, Madison County, Illinois, approved by the Mayor, and deposited in the office of the City Clerk this 21<sup>st</sup> day of March, 2016.

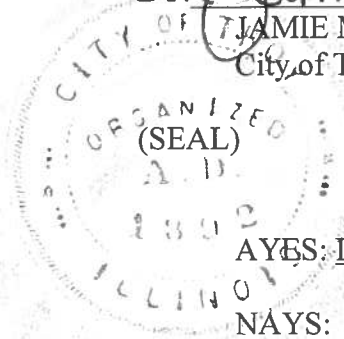
