**RESOLUTION NO. 2017 -16**

**A RESOLUTION OF THE CITY OF TROY, ILLINOIS  
SUPPORTING THE REHABILITATION FOR ILLINOIS LIQUOR  
CONTROL LICENSING FOR CHEF MARY GUTZLER**

**WHEREAS**, the City of Troy, Illinois, recognizes that the State of Illinois, under the State Liquor Control Act (235 ILCS 5/6-2(a)(4)), prohibits the licensing to any “person who has been convicted of a felony under any Federal or State law, unless the Commission determines that such person has been sufficiently rehabilitated to warrant the public trust after considering matters set forth in such person's application and the Commission's investigation;” and

**WHEREAS**, in 2002, Mary Gutzler was convicted of felony theft; and

**WHEREAS**, since that conviction, Mary Gutzler has assisted the operation of Gutzler’s Butterfly Patio through several ownership groups since 2014 in Troy and incorporated as Chef Gutzler’s Butterfly Patio LLC in January 2017; and

**WHEREAS**, in three-plus years in Troy, Chef Gutzler has provided catering services, private pre-prepared meals to clients, cooking classes, and presently offers a more full-service menu and regular restaurant hours in her destination gourmet business; and

**WHEREAS**, Chef Mary Gutzler has advanced her personal education with a culinary arts degree from Le Cordon Bleu in St. Peters, Missouri; and

**WHEREAS**, the City of Troy, Illinois, recognizes that the Illinois General Assembly has created a legislative and administrative remedy to the potential licensing of an applicant that has previously been convicted of a criminal felony through the proof of sufficient rehabilitation to warrant the public trust; and

**WHEREAS**, the City of Troy, Illinois, wishes to express that Chef Mary Gutzler has established public trust with the community of the City of Troy, Illinois, at a sufficient level to merit the possession of state liquor licensing.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TROY, ILLINOIS, AS FOLLOWS:**

1. The recitals set forth above are hereby incorporated herein as if fully set forth.
2. The City of Troy, Illinois, shall provide documentation of this Resolution to Chef Mary Gutzler and the Illinois State Liquor Control Commission as evidence towards rehabilitation under the State Liquor Control Act, per 235 ILCS 5/6-2(a)(4).

3. This Resolution shall be in effect following its passage, approval and publication as provided by law.
4. Any and all Resolutions, sections or subsections of Resolutions in conflict herewith are hereby repealed.

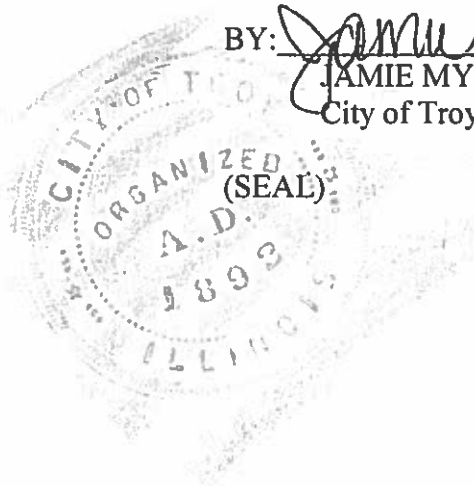
