**RESOLUTION CONCERNING THE DIVULGING OF ALL OR PORTIONS OF THE MINUTES OF VARIOUS
CLOSED MEETINGS HELD BY THE CITY COUNCIL OF THE CITY OF TROY, ILLINOIS**

WHEREAS, an amendment to Section 2.06 of the Open Meetings Act 5 ILCS 120/1 THROUGH 120/6 which became effective on January 1, 1989, requires that a public body periodically, but no less than semi-annually, meet to review minutes of all closed meetings, for the purpose of determining whether all or portions of the minutes of those meetings may be divulged; and

WHEREAS, the City Council of the City of Troy, Illinois, made such a review on April 30, 2018, of the minutes of all the closed meetings which were held from April 22, 2017 to April 16, 2018; and

WHEREAS, the City Council of the City of Troy, Illinois, also reviewed on April 30, 2018, the minutes of previously reviewed closed meetings which were held from June 7, 2010 to April 17, 2017; and

WHEREAS, from that review of the minutes of those closed meetings, the City Council of the City of Troy, Illinois, has determined that all or portions of the minutes of some of those closed meetings should be divulged, but that all or portions of the minutes of some of those closed meetings should remain confidential.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the following action shall be taken with respect to the minutes of all the closed meetings which it has held since April 22, 2017:

04/22/17 Divulge the entire minutes

05/09/17 Keep the entire contents confidential on the basis of 5 ILCS 120/2(c)5, the purchase or lease of real property for the use of the public body

05/15/17 Divulge the entire minutes

02/05/18 Keep the entire contents confidential on the basis of 5 ILCS 120/2(c)5, the purchase or lease of real property for the use of the public body, and 5 ILCS 120/2(c)11, potential litigation

04/02/18 Divulge the entire minutes

04/16/18 Divulge the contents including collective bargaining matters with the Police Dispatchers; keep the remainder of the contents confidential on the basis of 5 ILCS 120/2(c)5, the the purchase or lease of real property for the use of the public body

SECTION 2: That the following action shall be taken with respect to the minutes of other previously reviewed closed meetings, between February 20, 2001 and December 15, 2014, that contained contents determined by the City Council to be confidential under 5 ILCS 120/2, including the following meetings:

02/06/17 Divulge the entire minutes

SECTION 3: That the following action shall continue to be taken with respect to the minutes of all other previously reviewed closed meetings, including meetings between June 7, 2010 and April 17, 2017:

06/07/10 Keep the remaining contents confidential on the basis of 5 ILCS 120/2(c)11, the potential for litigation

03/18/13 Keep the entire contents confidential on the basis of 5 ILCS 120/2(c)1 employment and performance of a specific employee

05/20/13 Keep the entire contents confidential on the basis of 5 ILCS 120/2(c)1 employment and performance of a specific employee and 5ILCS 120/2(c)11 probable litigation

06/17/13 Keep the entire contents confidential on the basis of 5 ILCS 120/2(c)1 appointment, employment and performance of a specific employee

01/04/16 Keep the remaining contents confidential on the basis of 5 ILCS 120/2(c)11, the potential for litigation

11/07/16 Keep the entire contents confidential on the basis of 5 ILCS 120/2(c)11, the potential for litigation

03/06/17 Keep the remaining contents confidential on the basis of 5 ILCS 120/2(c)11, the potential for litigation

04/17/17 Keep the entire contents confidential on the basis of 5 ILCS 120/2(c)11, the potential for litigation

SECTION 4: That the City Clerk shall prepare copies of those portions of the minutes of these closed meetings which are to be opened and shall make those portions of the minutes available for public inspection within a reasonable time after the date of the adoption of this resolution, but that the City Clerk shall not divulge those portions of the minutes of the close meeting which the City Council has resolved to keep confidential.

SECTION 4: That this resolution shall take effect immediately.




