RESOLUTION NO. 2019 -10

RESOLUTION OF THE CITY OF TROY, ILLINOIS, RESCINDING RESOLUTION 2019-10, AND SUPPORTING THE APPLICATION TO THE METRO-EAST PARK AND RECREATION DISTRICT FOR THE FISCAL YEAR 2020 PARK AND TRAIL GRANT PROGRAM

WHEREAS, the City of Troy, Illinois, has identified an opportunity to enhance the City residents' access to a greater quality of life and recreation by creating a Splash Pad, utilizing City Tax-Increment Financing (TIF) funds, and to further utilize such funds to create and connect such Splash Pad to a centralized corridor for safe delivery of pedestrians and bicycles from downtown Troy to the Tri-Township Park District, and then to the Madison County Transit Brail Trail system; and

WHEREAS, on July 10, 2019, the City of Troy applied for \$300,000 in grant funds from the Metro-East Park and Recreation District; and

WHEREAS, it is the intention of the City of Troy to design, bid and construct a Splash Pad with an estimated total budget of \$1,500,000; and

WHEREAS, the City Council of the City of Troy, Illinois, supports the application to the Metro-East Park and Recreation District for \$300,000 in funding to offset the costs of construction of a Splash Pad.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TROY, ILLINOIS, AS FOLLOWS:

- 1. The recitals set forth above are hereby incorporated herein as if fully set forth.
- 2. The City of Troy, Illinois, apply for a Park and Trail Grant with the Metro-East Park and Recreation District for \$300,000 in funding for a Splash Pad with a project budget of \$1,500,000 (see Exhibit A).
- 3. That the Mayor, on behalf of the City of Troy, Illinois, execute such documents and all other documents necessary for the carrying out of said grant applications.
- 4. That the Mayor is authorized to provide such additional information as may be required to accomplish the obtaining of such grant.
- 5. This Resolution shall be in effect following its passage, approval and publication as provided by law.
- 6. Any and all Resolutions, sections or subsections of Resolutions in conflict herewith are hereby repealed, including the recension of Resolution 2019-10.
