RESOLUTION CONCERNING REVIEW OF CLOSED SESSION MINUTES HELD BY THE CITY COUNCIL OF THE CITY OF TROY, ILLINOIS FOR THE PERIOD ENDING SEPTEMBER 30, 2021

WHEREAS, the Troy City Council and its Committees are governed by the provisions of 5 ILCS 120, Illinois Open Meetings Act, concerning the management of minutes of closed session meetings of the Council and its Committees; and

WHEREAS, 5 ILCS 120, paragraph 2.06 (as amended) of the Open Meetings Act requires that a public body meet every six months, or as soon as practicable, to review the minutes of closed sessions and determine whether said minutes must remain closed or may be opened to public review; and

WHEREAS, the minutes of all closed sessions held through September 30, 2021, were reviewed by the Troy City Council on October 4, 2021; and

WHEREAS, the City Council has determined that all or portions of the minutes of some closed sessions should be divulged, and that all or portions of the minutes of some closed sessions should remain confidential.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:
