ORDINANCE NO. 017-25

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH **STRYKER MEDICAL DEVICES** FOR THE PURCHASE OF TWO (2) POWERED STAIR CHAIRS FOR THE FIRE DEPARTMENT AND DECLARING AN EMERGENCY

WHEREAS, the Fire Chief recommends that the City purchase two powered stair chairs to assist in life-saving services from the department and to help alleviate injuries to staff members which will be purchased using a credit owed by Stryker with the remaining balance being reimbursed by Ohio BWC.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. Council for the City of Bedford hereby authorizes the City Manager to enter into a contract with Stryker Medical Devices for the purchase of two (2) powered stair chairs for the total purchase amount of **Thirty-Two Thousand Three Hundred Forty-Five Dollars and Eighty-Six Cents (\$32,345.86)** and sign any documents necessary to facilitate the transaction.

Section 2. Council for the City of Bedford hereby authorizes the Finance Director to appropriate and pay the total after the application of the **Nine Thousand Five Hundred Eighty-Seven Dollars and Forty-Six Cents (\$9,587.46)** credit owed by Stryker the sum of **Twenty-Two Thousand Seven Hundred Fifty-Eight Dollars and Four Cents (\$22,758.04)** from **Fire Equipment Fund No. 212** to **Stryker Medical Devices** for said equipment.

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, safety, and welfare and for the further reason that the City of Bedford wants to immediately purchase said equipment to enhance services and assist firefighters.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest date permitted by law.
