ORDINANCE NO. 032-26

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH MRS DISTRIBUTION LLC FOR THE PURCHASE OF UV BULBS FOR THE DISINFECTION SYSTEM AT THE WASTEWATER TREATMENT PLANT ("WWTP") AND DECLARING AN EMERGENCY

WHEREAS, the Administration recommends purchasing the UV bulbs from MRS Distribution for the disinfection system at the WWTP, because the current bulbs have reached their useful hours and need to be replaced to continue efficient operations.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. The Council for the City of Bedford hereby authorizes the City Manager to enter into a contract with MRS Distribution LLC for the purchase of UV bulbs for the Disinfection System at the Wastewater Treatment Plant in the amount of **Twelve Thousand One Hundred Sixty Dollars and Zero Cents (\$12,160.00)**.

Section 2. The Council for the City of Bedford hereby authorizes the Finance Director to appropriate and pay MRS Distribution LLC for the purchase of UV bulbs for the disinfection system pursuant to the terms contained in the quote.


Section 3. That the actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, safety, and welfare of the City of Bedford, Ohio, due to the age of the current bulbs and to continue efficient services for the residents.


WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest date permitted by law.
