ORDINANCE NO. 067-24

AN ORDINANCE AMENDING ORDINANCE NO. 009-24 AUTHORIZING THE APPROVAL OF ENGINEERING FEE TO **GPD GROUP** FOR ITS SERVICES REGARDING DESIGN AND CONSTRUCTION ADMINISTRATION COSTS ASSOCIATED WITH THE **TURNEY ROAD** RESURFACING PROJECT IN THE CITY OF BEDFORD AND DECLARING AN EMERGENCY

WHEREAS, this project is known as the repair and resurfacing of Turney Road from Lee Road to West Grace in the City of Bedford, and

WHEREAS, this project consisted of three (3) inches of asphalt, base pavement will be repaired as needed, curbs will be removed and replaced as needed, ten (10) curb ramps will be replaced to meet current ADA standards, and reconstruct catch basins and manholes as required. Re-stripping of streets will also occur, as submitted in the GPD Proposal, and

WHEREAS, the project was primarily funded by a grant from Cuyahoga County with a maximum of **Two Hundred Fifty Thousand Dollars and Zero Cents (\$250,000.00)** with the City being responsible for the remaining costs, and

WHEREAS, the Administration recommended GPD Group perform Engineering Design and Construction Administration for the project.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. Council for the City of Bedford authorized the City Manager to contract with GPD Group for Engineering Design Costs for said project per the attached proposal which required additional services not contained in the original proposal of **Fourteen Thousand Nine Hundred Seventy-One Dollars and Seventy-Five Cents \$14,971.75**.

Section 2. The Finance Director of the City of Bedford is hereby authorized to appropriate and pay the original sum not to exceed **Sixty-Three Thousand Five Hundred Dollars and Zero Cents (\$63,500.00)** and the additional sum not to exceed **Fourteen Thousand Nine Hundred Seventy-One Dollars and Seventy-Five Cents (\$14,971.75)** from **Capital Improvements Fund No. 403** to GPD Group for said Design and Construction Administration Costs.

Section 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the public peace, health, safety, and welfare of the City of Bedford and for the further the City desires to immediately pay for said expenditures for the project.
