RESOLUTION NO. 2634-25

A RESOLUTION AUTHORIZING THE CITY MANAGER OF THE CITY OF BEDFORD TO ENTER INTO A TWO (2) YEAR CONTRACT ON BEHALF OF THE CITY OF BEDFORD WITH THE GENERAL HEALTH DISTRICT OF CUYAHOGA COUNTY FOR HEALTH SERVICES FOR THE YEARS **2026** AND **2027** AND DECLARING AN EMERGENCY

WHEREAS, the City of Bedford has no Health Department of its own, and

WHEREAS, this Council wishes to contract for health services for the City of Bedford with the General Health District of Cuyahoga County as required by Chapter 3709 of the Ohio Revised Code.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Bedford, County of Cuyahoga, and the State of Ohio:

Section 1. That the City Manager of the City of Bedford, Ohio, be and he is hereby authorized to enter into a two (2) year contract on behalf of this City with the General Health District of Cuyahoga County, Ohio, for the furnishings to the City of Bedford all necessary medical, nursing, sanitary, laboratory and such other health services as is required by the Statutes of the State of Ohio.

Section 2. That such service, authorized in Section 1, hereof, shall be for the calendar years **2026** and **2027** and the City of Bedford, Ohio, agrees to pay to said General Health District of Cuyahoga County, Ohio, the sum of One Hundred Seventeen Thousand Eight Hundred Fifteen Dollars and Zero Cents (\$117,815.00) for the calendar year 2026 and One Hundred Thirty-Two Thousand Sixteen Dollars and Zero Cents (\$132,016.00) for the calendar year 2027 such services and shall be appropriated from the General Fund 110 for such purposes.

Section 3. That the Auditor of Cuyahoga County, Ohio, is hereby authorized to deduct said sum of One Hundred Seventeen Thousand Eight Hundred Fifteen Dollars and Zero Cents (\$117,815.00) for the calendar year 2026 and One Hundred Thirty-Two Thousand Sixteen Dollars and Zero Cents (\$132,016.00) for the calendar year 2027 in equal semi-annual installments of Fifty-Eight Thousand Nine Hundred and Seven Dollars and Fifty Cents (\$58,907.50) for the calendar year 2026 and Sixty-Six Thousand and Eight Dollars and Zero Cents (\$66,008.00) for calendar year 2027 each from the regular tax settlements to be made for said City of Bedford for the years **2026** and **2027**.

Section 4. That the Clerk of Council is hereby authorized and directed to forward a certified copy of this Resolution to the President of the District Advisory Council of the General Health District of Cuyahoga County, Ohio, and to the Auditor of Cuyahoga County.

Section 5. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public and in compliance with the law.
