These ordinances close Fund 898-9601, I-40 Sewer Line Repair Project. This project replaced approximately 500' of sewer line running under I-40 with ductile iron line based on corrosion and failure of the former steel casing line. In the Small Capital - Water & Sewer Fund (Fund 898), close Department 9601 for the the Sewer Line (under I-40) and return the remaining \$5,574.50 to the Water & Sewer Fund (Fund 330) as the project is complete.

All ordinances, or parts thereof conflicting or inconsistent with the provisions of this ordinance are hereby repealed. The City Council hereby declares that should any section, paragraph, sentence or word of this ordinance be declared for any reason invalid, it is the intent of the City Council that it would have passed all other portions of this ordinance independent of elimination herefrom of any such portion that may be declared invalid. This ordinance shall take effect and be in force from and after the date of its adoption.
