A RESOLUTION OF THE CITY OF CORRY ALLOCATING UP TO \$25,000 OF STATE AND LOCAL FISCAL RECOVERY FUNDS (SLFRF) FOR USE IN COMPLETING THE CORRY LAWRENCE AIRPORT CREDIT CARD UPGRADE AND FUEL TANK CONVERSION PROJECT.

WHEREAS, on March 11, 2021, the American Rescue Plan Act of 2021 was enacted and established the Coronavirus State Fiscal Recovery Fund and Coronavirus Local Fiscal Recovery Fund, which together make up the Coronavirus State and Local Fiscal Recovery Funds ("SLFRF");

WHEREAS, the City of Corry was awarded a total of Six Hundred Fifty-One Thousand, Eight Hundred Forty Dollars and Ninety-Two Cents (\$651,840.92);

WHEREAS, ARPA/SLFRF guidance identifies several eligible uses for the funds provided under ARPA/SLFRF;

WHEREAS, the Corry Airport Authority ("CAA") is preparing for an upgrade to the fuel system credit card system and the conversion of the fuel tank;

WHEREAS, the Board of the Corry Airport Authority has requested that the City use up to \$25,000 of the funds provided to the City under ARPA/SLFRF to assist CAA in completing the fuel system credit card upgrade and the conversion of the fuel tank;

WHEREAS, City Council has determined that work to be performed by CAA relative to the fuel system credit card upgrade and the conversion of the fuel tank project qualifies as an project eligible for funds under the SLFRF;

WHEREAS, City Council has determined it do be in the best interests of the City to allocate up to \$25,000 of the funds provided to the City under ARPA/SLFRF to facilitate CAA's completion of the fuel system credit card upgrade and the conversion of the fuel tank;


WHEREAS, City Council has determined that the use of ARPA/SLFRF funds for this fuel system credit card upgrade and the conversion of the fuel tank project is compliant with ARPA/SLFRF and is in the best interests of the City.

IT IS HEREBY RESOLVED by the City Council of the City of Corry, Erie County, Pennsylvania as follows:


1. The City of Corry hereby allocates up to \$25,000 of funds awarded to the City under ARPA/SLFRF to be used for CAA's fuel system credit card upgrade and the conversion of the fuel tank.
2. The allocated funds shall be held by the City. The City shall make payments directly to CAA's vendors for services as part of the fuel system credit card upgrade and the conversion of the fuel tank project.
3. The City Administrator and the Mayor are authorized to execute any and all documents necessary to accomplish the allocation of ARPA/SLFRF to CAA's fuel system credit card upgrade and the conversion of the fuel tank project.
4. This Resolution shall be effective immediately.
