A RESOLUTION OF THE CITY OF CORRY ALLOCATING UP TO \$19,750.00 OF STATE AND LOCAL FISCAL RECOVERY FUNDS (SLFRF) FOR THE FIRE STATION EAST SOUTH STREET CONCRETE APRON PROJECT.

WHEREAS, on March 11, 2021, the American Rescue Plan Act of 2021 was enacted and established the Coronavirus State Fiscal Recovery Fund and Coronavirus Local Fiscal Recovery Fund, which together make up the Coronavirus State and Local Fiscal Recovery Funds ("SLFRF");

WHEREAS, the City of Corry was awarded a total of Six Hundred Fifty-One Thousand, Eight Hundred Forty Dollars and Ninety-Two Cents (\$651,840.92);

WHEREAS, ARPA/SLFRF guidance identifies several eligible uses for the funds provided under ARPA/SLFRF;

WHEREAS, the City of Corry needs a new concrete apron at the Fire Station on East South Street;

WHEREAS, the City of Corry Fire Department has requested that the City use up to \$19,750.00 of the funds provided to the City ARPA/SLFRF to replace the East South Street concrete apron at the Fire Station;

WHEREAS, City Council has determined that the replacement concrete apron project qualifies as a project eligible for funds under the SLFRF;

WHEREAS, City Council has determined it to be in the best interests of the City to allocate up to \$19,750.00 of the funds provided to the City under ARPA/SLFRF to facilitate the East South Street concrete apron at the Fire Station;

WHEREAS, City Council has determined that the use of ARPA/SLFRF funds for this purchase is compliant with ARPA/SLFRF and is in the best interests of the City.

IT IS HEREBY RESOLVED by the City Council of the City of Corry, Erie County, Pennsylvania as follows:

1. The City of Corry hereby allocates up to \$19,750.00 of funds awarded to the City under ARPA/SLFRF to be used for the East South Street concrete apron at the Fire Station.
2. The allocated funds shall be held by the City. The City shall make payments directly to the vendor.
3. The City Administrator and the Mayor are authorized to execute any and all documents necessary to accomplish the allocation of ARPA/SLFRF.
4. This Resolution shall be effective immediately.
