

# CITY OF CORRY RESOLUTION

**A RESOLUTION OF THE CORRY CITY COUNCIL  
AUTHORIZING THE SALE OF CITY PROPERTY,  
SPECIFICALLY A 1998 FREIGHTLINER DIESEL PUMPER  
FIRE TRUCK, VALUED AT MORE THAN \$2,000 BY  
MEANS OF SEALED BID OR AUCTION OR MUNICIBID  
(Online Government Auction).**

**WHEREAS**, pursuant to Section 12402.1(c)(1) of the Third Class City Code, 11 Pa. C.S.A. § 12402.1(c)(1), no personal property of the city shall be disposed of, by sale or otherwise, except upon approval of council by resolution;

**WHEREAS**, Section 12402.1(c)(4) also provides that if the estimated value of the property is \$2,000 or more, the entire lot shall be advertised for sale in at least one newspaper; and

**WHEREAS**, Section 12402.1(c)(4) permits City Council to sell the property by bid, provided the notice requirements of Section 12402.1(c).

**WHEREAS**, Section 12402.1(c)(7) permits City Council to sell the property at auction pursuant to Section 12402.1(d), provided the notice requirements of Section 12402.1(c).

**WHEREAS**, the Director of Public Safety and Fire Chief have identified a piece of City owned equipment, specifically a 1998 Freightliner Diesel Pumper Fire Truck ("City Personal Property"), that is no longer necessary for City operations and that the estimated value of the item is more than \$2,000; and

**WHEREAS**, City Council, based on the recommendation of the Director of Public Safety and Fire Chief, deems it to be in the best interests of the City to offer for sale by sealed bid or auction the item listed above.

**NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED** by the City Council of Corry, Erie County, Pennsylvania, as follows:

**Section 1.** The foregoing background recitals are incorporated into and made a substantive portion of this Resolution.

**Section 2.** Value of the Personal Property. City Council hereby determines that the estimated sale value of the Personal Property identified above is \$2,000 or more.

**Section 3.** Authorization to Sell Personal Property by Sealed Bid or Auction. In accordance with 42 Pa. C.S.A. §§ 12402.1(c) and 12402.1(d), City Council hereby authorizes the sale of City Personal Property set forth above by means of sealed bid or auction or Muncibid (Online Government Auctions).

**Section 4. Notice.** The City Administrator is hereby directed to comply with the advertising and notice provisions of 42 Pa. C.S.A. §§ 12402.1(c) and 12402.1(d).

**Section 5.** In the event any provision, section, sentence, clause or part of this Resolution shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Resolution, it being the intent of the City Council of Corry that the remainder of the Resolution shall be and shall remain in full force and effect.


**Section 6.** This Resolution shall take effect and be in force immediately.
