ORDINANCE NO. \_\_\_\_\_

An ordinance amending Chapter 28, "Motor Vehicles and Traffic," of the Dallas City Code by amending Sections 28-44, 28-50, 28-60, and 28-81.1; designating speed regulations on streets other than expressways; designating school traffic zones; providing bike lanes as a prohibited place to stop, stand, or park; providing a penalty not to exceed \$200; providing a saving clause; providing a severability clause; and providing an effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That Section 28-44, "Streets Other than Expressways and Freeways," of Division 2, "Speed Regulations," of Article VI, "Operation of Vehicles," of Chapter 28, "Motor Vehicles and Traffic," of the Dallas City Code is amended by alphabetically adding and deleting the following described streets where the speed of motor vehicles is limited as follows:

SECTION 2. That Subsection (c) of Section 28-50, "Speed in School Zones; Signs; Designated Streets," of Division 2, "Speed Regulations," of Article VI, "Operation of Vehicles," of Chapter 28, "Motor Vehicles and Traffic," of the Dallas City Code is amended by alphabetically adding and deleting the following described streets designated as school traffic zones where the speed of motor vehicles is limited to 20 miles per hour:

SECTION 3. That Subsection (b) of Section 28-60, "One-Way Streets in School Zones," of Article VII, "One-Way Streets and Alleys," of Chapter 28, "Motor Vehicles and Traffic," of the Dallas City Code is amended by adding the following described street designated as a school traffic zone where the speed of motor vehicles is limited to 20 miles per hour:

**ADDITIONS**

"Waterfall Way	Rolling Hills Lane to Brookgreen Drive	South"

SECTION 4. That Subsection (a) of Section 28-81.1, “Stopping, Standing, or Parking Prohibited in Specific Places,” of Division 1, “Generally,” of Article XI, “Stopping, Standing, and Parking Generally,” of Chapter 28, “Motor Vehicles and Traffic,” of the Dallas City Code is amended by adding the following:

“(a) Except when necessary to avoid conflict with other traffic or to be in compliance with the law or the directions of a police officer, a traffic and parking controller, or an official traffic-control device, a person commits an offense if he:

- (1) stops, stands, or parks a vehicle:
  - (A) on the roadway side of any vehicle stopped or parked at the edge or curb of a street;
  - (B) on a sidewalk;
  - (C) within an intersection;
  - (D) on a crosswalk;
  - (E) between a safety zone and the adjacent curb or within 30 feet of points on the curb immediately opposite the ends of a safety zone, unless a different length is indicated by signs or markings;
  - (F) alongside or opposite any street excavation or obstruction when stopping, standing, or parking would obstruct traffic;
  - (G) upon any bridge or other elevated structure upon a highway or within a highway tunnel;
  - (H) on any railroad track;
  - (I) on the roadway of any street, when the vehicle constitutes a hazard to itself or to persons or other vehicles; ~~[or]~~
  - (J) in violation of a sign prohibiting the stopping of vehicles; or
  - (K) in designated bike lanes; or
- (2) stands or parks a vehicle:
  - (A) in front of a public or private driveway;
  - (B) within 15 feet of a fire hydrant;

- (C) within 20 feet of a crosswalk at an intersection;
- (D) within 30 feet upon the approach to any flashing signal, stop sign, yield sign, or traffic-control signal located at the side of a roadway;
- (E) when properly posted with signs, within 20 feet of the driveway entrance to any fire station and, on the side of a street opposite the entrance to any fire station, within 75 feet of the entrance;
- (F) in violation of a sign prohibiting the standing of vehicles; or
- (G) in a fire lane[-]; or
- (H) in designated bike lanes.”

SECTION 5. That a person violating a provision of this ordinance, upon conviction, is punishable by a fine not to exceed \$200.

SECTION 6. That Chapter 28 of the Dallas City Code shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 7. That any act done or right vested or accrued, or any proceeding, suit, or prosecution had or commenced in any action before the amendment or repeal of any ordinance, or part thereof, shall not be affected or impaired by amendment or repeal of any ordinance, or part thereof, and shall be treated as still remaining in full force and effect for all intents and purposes as if the amended or repealed ordinance, or part thereof, had remained in force.

SECTION 8. That the terms and provisions of this ordinance are severable and are governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.
