

**VILLAGE OF HANNA CITY

ORDINANCE NO. 20-11-01

AN ORDINANCE ESTABLISHING A CLASS II TRUCK ROUTE FOR THE VILLAGE OF
HANNA CITY, ILLINOIS

WHEREAS, pursuant to 625 ILCS 5/20-204, the corporate authorities of the Village of Hanna City are authorized to adopt all or any portion of the Illinois Vehicle Code by reference; and

WHEREAS, pursuant to 625 ILCS 5/1-126.1(d), the corporate authorities of the Village of Hanna City may designate Class II highways within its system of highways; and

WHEREAS, pursuant to 625 ILCS 5/15-316(f), the corporate authorities of the Village of Hanna City are authorized to enforce the oversize vehicle ordinance of Peoria County applying to Peoria County highways within the corporate limits of the Village of Hanna City; and

WHEREAS, the corporate authorities of the Village of Hanna City have deemed it necessary and in the best interest of the Village to designate a Class II truck route and enforce the oversize vehicle ordinance of Peoria County.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hanna City, Peoria County, Illinois, as follows:

Section 1. The foregoing recitals are hereby incorporated herein as if fully set forth.

Section 2. Adoption of Peoria County Oversize Vehicle Ordinance

The Village of Hanna City hereby adopts the oversize vehicle ordinance of Peoria County (Ord. of 12-9-97), codified at Sec. 15-3 of the Peoria County Code of Ordinances, in its entirety.

Section 3. Truck Routes – Designation of Class II Truck Route and Prohibitions

There is hereby established within the Village of Hanna City the following Class II truck route:

- (a) Entering the Village from Illinois Route 116 (Farmington Road); South on Main Street to W. Hanna Street; turn onto Glasford Road.
- (b) Entering the Village from Illinois Route 116 (Farmington Road); North on First Street to Chicago Street; East on Chicago Street to Main Street; South on Main Street.
- (c) Entering the Village from Illinois Route 116 (Farmington Road); North on Main Street to Chicago Street; West on Chicago Street to First Street; South on First Street to Illinois Route 116 (Farmington Road).
- (d) Entering the Village from S. Hanna City Glasford Road; East on Hanna Street; turn South onto Second Street or continue East to Main Street and turn North.

- (e) No commercial motor vehicles shall be permitted on N. Runkle Street, First Street (excluding the portion of First Street between Illinois Route 116 and Chicago Street), Second Street, or Third Street, unless otherwise provided for hereunder.

All streets not designated as truck routes shall be residential streets. Truck routes may be designated by ordinance or resolution of the corporate authorities of the Village of Hanna City.

In accordance with 625 ILCS 5/11-207, the City shall post proper signage giving reasonable notice of the Class II truck route established herein.

Section 4. Exceptions


The provisions of this Ordinance governing size, weight, and load do not apply to fire apparatus or equipment for snow and ice removal operations owned or operated by any governmental body. Further, the provisions of this Ordinance shall not apply to commercial motor vehicles used for local residential deliveries.

Section 5. Should any portion of this Ordinance be held invalid or illegal, the remaining portions hereof shall continue in full force and effect.

Section 6. This Ordinance shall be in full force and effect following its passage, publication and approval as required by law.
