ORDINANCE NO. 22- 04 - 01

AN ORDINANCE AMENDING THE MINIMUM WATER AND COMBINED WATER  
RATES FOR RESIDENTIAL AND NONRESIDENTIAL CUSTOMERS IN THE VILLAGE  
OF HANNA CITY

WHEREAS, the Village of Hanna City has the authority to adopt ordinances and to promulgate rules and regulations that protect the public health, safety and welfare of its citizens; and

WHEREAS, pursuant to 65 ILCS 5/11-126-4, the corporate authorities of the Village of Hanna City are authorized to fix and collect from the Village's inhabitants the rates for the use and benefit of water supplied to them; and

WHEREAS, the Village of Hanna City has experienced financial losses related to water usage by the Village's residents; and

WHEREAS, the President and Board of Trustees of the Village of Hanna City have determined that a modest increase to the service charges for water usage to defray the Village's costs with respect to water usage is in the best interest of the Village and its residents;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hanna City, Peoria County, Illinois, as follows:

**Section 1.** The foregoing recitals are hereby incorporated as if fully set forth herein.

**Section 2.** Title V, Public works, Chapter 51, Section 51.05 of the Village of Hanna City Code of Ordinances is hereby amended with respect to monthly water service charges as follows:

The minimum water fee for water service shall be \$27.00 per month for the first 2,000 gallons of water consumed per month.

For water consumption greater than 2000 gallons and up to 70,000 gallons per month, the water service charge shall be \$8.50 per 1,000 gallons of water consumed per month.

For water consumption greater than 2000 gallons and exceeding 70,000 gallons per month, the water service charge shall be \$5.00 per 1,000 gallons of water consumed per month.

**Section 3.** Should any portion of this Ordinance be held invalid or illegal, the remaining portions hereof shall continue in full force and effect.

**Section 4.** Any ordinance or ordinances of the Village of Hanna City in conflict with this Ordinance shall be repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect as early as May 1, 2022 following its passage, approval, and publication in pamphlet form as required by law; however, the Board of Trustees may delay implementation of the increase in water service charges beyond May 1, 2022 in its discretion.
