ORDINANCE NO. 11 SERIES 2024**

**AN ORDINANCE ADOPTING THE CITY OF LAGRANGE, KENTUCKY
ANNUAL STORM WATER MS4 FOR THE FISCAL YEAR JULY 1, 2024, THROUGH JUNE 30, 2025,**

WHEREAS, an annual budget for the Storm Water MS4 proposal and message has been prepared and delivered to the City Council of LaGrange, Kentucky; and

WHEREAS, the City Council has reviewed such budget proposal and accepted same as presented;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAGRANGE, KENTUCKY:

SECTION I

The annual budget for Storm Water MS4 for the fiscal year beginning July 1, 2024, and ending June 30, 2025, is hereby adopted as follows:

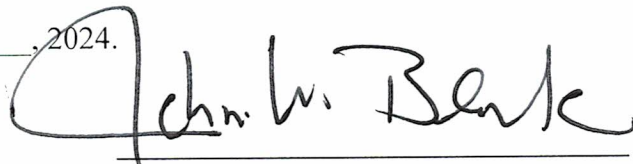
This Ordinance shall take effect upon its passage, approval, and publication, according to law, and shall continue until amended or until June 30, 2024, whichever should first occur.
