AN ORDINANCE AMENDING CHAPTER 58. OFFENSES AND MISCELLANEOUS PROVISIONS. ARTICLE V. CANNABIS AND DRUG PARAPHERNALIA. SECTION 58-96. UNLAWFUL USE OR POSSESSION OF DRUG PARAPHERNALIA.

BE IT ORDAINED by the City Council of the City of Marshall, Illinois:

Section 1. That Chapter 58. Offenses and Miscellaneous Provisions. Article V. Cannabis and Drug Paraphernalia. Section 58-96. Unlawful Use or Possession of Drug Paraphernalia of the Code of Ordinances, City of Marshall, Illinois is hereby amended to read as follows, with strikeouts indicating deletions in text and underscores indicating additions to text:

Section 58-96. Unlawful use or possession of drug paraphernalia.

This ordinance recognizes (720 ILCS 600) Drug Paraphernalia Control Act for the restrictions regarding possession, use, and sale of drug paraphernalia in the City of Marshall.

Any person(s), entity, organization, partnership or corporation convicted of violating this ordinance shall be punished by a fine of not less than ~~five dollars (\$50.00)~~ one hundred dollars (\$100.00) or more than ~~seventy-five (\$75.00)~~ two hundred dollars (\$200.00) per day of occurrence.
