## AN ORDINANCE AUTHORIZING SALE OF MUNICIPAL PROPERTY

WHEREAS, the City Council of the City of Mt. Vernon, Illinois has been advised by the City Manager that the property described within the attached Schedule is no longer necessary, useful to or for the best interest of the City of Mt. Vernon to retain; and

WHEREAS, the City Council of the City of Mt. Vernon, Illinois has determined that the City Manager should be authorized to dispose of said property by private or public sale with or without advertising in accordance with the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Mt. Vernon, Illinois as follows:

Section 1: That the above-described property now owned by the City of Mt. Vernon is no longer necessary or useful to the City of Mt. Vernon and the best interests of the municipality will be served by sale of same.

Section 2: That the City Manager is authorized and directed to sell the property at private or public sales, with or without advertising, in accordance with the best interests of the City.

Section 3: That this Ordinance shall be in full force and effect from and after its passage by at least four-fifths of the City Council and approved in the matter provided by law.
