

ORDINANCE NO. 10505 (NEW SERIES)

ORDINANCE AMENDING SECTION 439.2 OF THE SAN DIEGO COUNTY CODE OF ADMINISTRATIVE ORDINANCES RELATING TO FEE ADJUSTMENTS FOR THE REGISTRAR OF VOTERS RECORDS AND SERVICES

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. Purpose. The Registrar of Voters (ROV) is responsible for the overall administration of federal, state, and local elections and the maintenance of voter registration records for the County of San Diego. As part of its business the ROV charges and collects fees for providing various election and voter file related products and services to candidates and campaigns, government agencies, the media and other members of the public.

Section 2. This ordinance amends Section 439.2 of the County Code of Administrative Ordinances to adjust Registrar of Voters product and service fees effective for Fiscal Year 2017-2018 (and thereafter unless further amended). Fees for some products and services have been restructured and simplified. In addition, the ROV has achieved efficiencies in many areas since fees were last adjusted, and in some areas, those efficiencies are sufficient to offset higher costs, so that some fees are reduced or have become obsolete.

Section 3. Section 439.2 of the San Diego County Code of Administrative Ordinances is amended to read as follows:

SEC. 439.2. FEES FOR RECORDS AND SERVICES.

The Registrar of Voters may charge and collect the following fees in connection with providing to members of the public the records and services indicated:

(a) Retrieval and copying of campaign financial records pursuant to Government Code section 81008

1. Records over five years old . . . \$5 per request
2. Copies of campaign records . . . \$.10 per page

(b) Searching records or files

1. Staff research: \$92 per hour
2. Technical support: \$182 per hour

(c) Computer generated data and reports

1. Electronic transfer of absentee vote by mail voter information via FTP (file uploaded on a daily/weekly basis): \$306

2. Vote by mail voter data CD (one-time service): \$115

3. Voter file CD

a. Countywide: \$35

b. Selection by jurisdiction:

up to 300,000 registered voters: \$37

300,001 – 750,000 registered voters: \$40

750,001 and above registered voters: \$42

4. Voter registration list pursuant to Elections Code 2184 with special master voter file sort: \$.50 per 1,000 names

(d) Candidate statements pursuant to Elections Code 13307 (not to exceed 200 words except when noted):

1. Representatives in Congress (250 words): \$322 set-up fee, plus \$7 per 1,000 registered voters

2. State Senate (250 words): \$322 set-up fee, plus \$8 per 1,000 registered voters

3. State Assembly (250 words): \$322 set-up fee, plus \$8 per 1,000 registered voters

4. Countywide Office & Superior Court: \$301 set-up fee, plus \$6 per 1,000 registered voters

5. County Board of Supervisors & County Board of Education: \$301 set-up fee, plus \$6 per 1,000 registered voters

6. Community College Districts

a. 200 Words: \$301 set-up fee, plus \$7 per 1,000 registered voters

b. 400 Words: \$551 set-up fee, plus \$9 per 1,000 registered voters

7. School Districts:

a. 200 words: \$301 set-up fee, plus \$7 per 1,000 registered voters

b. 200 words with photo: \$426 set-up fee, plus \$5 per 1,000 registered voters

c. 400 words: \$551 set-up fee, plus \$14 per 1,000 registered voters

8. Special Districts:

a. 200 words: \$301 set-up fee, plus \$8 per 1,000 registered voters

b. 400 words: \$551 set-up fee, plus \$13 per 1,000 registered voters

c. Healthcare Districts: \$301 set-up fee, plus \$6 per 1,000 registered voters

(e) Certification of documents: \$1.50 per document pursuant to Elections Code 2167

(f) Notice of intent to circulate County initiative petition pursuant to Elections Code 9103(b):
\$200 (to be refunded if petition is certified sufficient within one year of the date of filing)

(g) Maps

1. Customer-ready maps – Countywide with communities, district boundaries and roads (36" x 48") \$8
2. Custom maps: \$98 per hour development charge, plus materials cost as follows:
 - Up to 11" X 17" no charge
 - 24" x 36" \$3.00
 - 36" x 48" \$6.00
 - CD \$1.00
 - Transparency 36" x 48" \$12.00
 - Mailing Tube \$2.00

Custom maps include communities, district boundaries, roads, parcels and precincts as specified in the map order. Additional copies provided at materials cost only.

Section 4. Effective Date. This Ordinance shall take effect 30 days after its adoption. Within 15 days after the date of adoption of this ordinance, a summary shall be published once with the names of the members voting for and against the same in a newspaper of general circulation published in the County of San Diego.


