ORDINANCE NO. 10746 (NEW SERIES)

**ORDINANCE AMENDING SECTIONS 72.162.33., 72.169.7., 72.169.7.1., 72.169.88.,
AND 72.173. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS
ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY**

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.162.33. of the San Diego County Code is amended to read as follows:
SEC. 72.162.33. RANCHO SANTA FE. The prima facie speed limit on El Camino Real from the south line of Linea del Cielo to the San Diego City Limit (near Rancho del Madison) is hereby decreased to and established at 40 miles per hour.

Section 72.169.7. of the San Diego County Code is amended to read as follows:
SEC. 72.169.7. FALLBROOK. The prima facie speed limit on Alvarado Street between the easterly line of Brandon Road (North) and the westerly line of Stage Coach Lane is hereby decreased to and established at 35 miles per hour.

Section 72.169.7.1. of the San Diego County Code is amended to read as follows:
SEC. 72.169.7.1. FALLBROOK. The prima facie speed limit on Alvarado Street from the east line of Stage Coach Lane easterly to the west line of Live Oak Park Road is hereby decreased to and established at 30 miles per hour.


Section 72.169.88. of the San Diego County Code is amended to read as follows:
SEC. 72.169.88. ALPINE. The prima facie speed limit on Tavern Road from the north line of South Grade Road northerly to the south line of Arnold Way is hereby decreased to and established at 40 miles per hour.

Section 72.173. of the San Diego County Code is amended to read as follows:
SEC. 72.173. BONITA. The prima facie speed limit on Corral Canyon Road from the south line of Central Avenue to the Chula Vista City Limit is hereby decreased to and established at 30 miles per hour.


