

ORDINANCE NO. 10759 (NEW SERIES)

AN ORDINANCE AMENDING THE SAN DIEGO COUNTY CODE OF ADMINISTRATIVE ORDINANCES ARTICLE XXII RELATING TO THE DEPARTMENT OF PLANNING & DEVELOPMENT SERVICES TO UPDATE AND CLARIFY EXISTING PROCEDURES FOR FEES AND PROCESSING RELATED TO SPECIFIC AND GENERAL PLAN AMENDMENTS AND ELIMINATE INFORMATION THAT IS NO LONGER NECESSARY FOR FARM EMPLOYEE HOUSING AND FARM LABOR CAMPS

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. Purpose.

The Board of Supervisors finds and determines that the amendments made by this ordinance are intended to implement changes to the Specific Plan Deposit and Fee and the General Plan Amendment Fees in order to update the process of which department the required deposits and fees are remitted to and further clarify the process, and to repeal the section on the Waiver of Specified Fees for Farm Employee Housing and Farm Labor Camps as this process is no longer in use.

Section 2. Section 395 of the San Diego County Administrative Code is hereby amended to read as follows:

SEC. 395. SPECIFIC PLAN DEPOSIT AND FEE.

When an application is submitted for a specific plan or specific plan amendment, the deposit described below shall be paid to the Department of Planning & Development Services and the fee or fees described below shall be paid to the Department of Planning & Development Services.

- (a) A deposit shall be paid to the Department of Planning & Development Services in an amount sufficient to cover the actual cost to review and process the application.
- (b) A non-refundable fee or fees shall be paid to the Department of Planning & Development Services for the Department's costs to review the application for trails requirements.
- (c) The amount of the deposit and fees shall be determined by the Board of Supervisors.

Section 3. Section 395.1 of the San Diego County Administrative Code is hereby amended to read as follows:

SEC. 395.1. GENERAL PLAN AMENDMENT FEES.

- (a) When an application is submitted for a General Plan amendment, the applicant shall pay to the Department of Planning & Development Services a deposit sufficient to cover the actual cost of processing the application.
- (b) When an application is submitted for a General Plan amendment, the applicant shall pay to the Department of Planning & Development Services a non-refundable fee or fees for the Department's costs to review the application for trails requirements.
- (c) The amount of the deposit and fees shall be determined by the Board of Supervisors.

Section 4. Section 395.3 of the San Diego County Administrative Code is hereby repealed.




