

**AN ORDINANCE AMENDING SECTION 31.203 OF THE SAN DIEGO COUNTY CODE RELATING TO THE VOLUNTEER RESERVE FIREFIGHTER PROGRAM**

ORDINANCE NO. 10859 (N.S.)

AN ORDINANCE AMENDING THE SAN DIEGO COUNTY CODE ARTICLE 31 SECTION 203, RELATING TO THE VOLUNTEER RESERVE FIREFIGHTER PROGRAM

The Board of Supervisors of the County of San Diego ordains as follows:

**Section 1.** Section 31.203 of the San Diego County Code is hereby amended to read as follows:

**SECTION 31.203. VOLUNTEER RESERVE FIREFIGHTER STIPEND.**


- (a) Persons serving as Volunteer Reserve Firefighters for San Diego County Fire, shall be paid a stipend allowance to offset the costs these volunteers may incur for each shift worked. The allowance is meant to reimburse the volunteers for expenses related to travel, food, equipment, and training related to the preparation for and provision of firefighting and emergency medical services. The allowance also provides a nominal stipend based upon the position assigned.
- (b) Stipend Amounts. Specific stipend amounts are listed by Volunteer Reserve Firefighter assignments:

<u>Assignment</u>	<u>Stipend Amount</u>
Restricted Volunteer Reserve	\$192
Full Volunteer Reserve	\$384

Section 5. This ordinance shall take effect and be in force thirty days after its passage, and before the expiration of fifteen days after its passage, a summary hereof shall be published once with the names of the members of this Board voting for and against it in the Daily Transcript, a newspaper of general circulation published in the County of San Diego.
