# Ordinance No. 2024 - 22

An Ordinance Amending Certain Sections of Title III: Administration, Chapters 32: and 38 of the Codified Ordinances of the City of Troy, Illinois Regarding Compensation of Employees Appointed to Serve as the Assistant to the Mayor as Local Liquor Control Commissioner and FOIA Officer

ADOPTED BY THE CITY COUNCIL OF THE CITY OF TROY, ILLINOIS

This <u>Sixth</u> Day of <u>May</u>, 2024

WHEREAS, the Mayor and City Council of the City of Troy, Madison County, Illinois, has the authority to adopt ordinances and promulgate rules and regulations that pertain to its government; and

WHEREAS, the City Council of the City of Troy has reviewed the provisions of the current text of Chapters 32 and 38 of the Code of Ordinances and determined that they require certain amendments to encourage effective management of City funds; and

WHEREAS, the City Council of the City of Troy has duly considered the matter and has concluded that it is in the best interest of the City and its citizens to provide compensation for individuals appointed to serve the City of Troy as the Assistant to the Mayor as Local Liquor Control Commissioner and FOIA Officer.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Troy, Madison County, Illinois as follows:

<u>Section 1:</u> The facts and statements contained in the preamble to this Ordinance are found to be true and correct and hereby adopted as part of this Ordinance.

<u>Section 2:</u> The Troy Municipal Code, Title III Administration, Chapter 32: Officers, Employees and Other Workers, Section 32.039 Assistant to the Mayor and Local Liquor Control Commissioner shall be amended to read as follows:

# § 32.039 ASSISTANT TO THE MAYOR AND AS LOCAL LIQUOR CONTROL COMMISSIONER.

- (A) There is hereby created the position of Assistant to the Mayor and as Local Liquor Control Commissioner of the city.
- (B) The Mayor with the advice and consent of the corporate authorities shall appoint the Assistant to the Mayor and as Local Liquor Control Commissioner.
- (C) The initial term of the appointment shall be from the effective date hereof to April 30, 2005. Thereafter, the The appointment shall be an annual appointment for one year from May 1 to April 30.
- (D) The Assistant to the Mayor as Local Liquor Control Commissioner shall receive a 75-cent hourly premium that will be added to the employee's base pay.
- (E) The assistant to the Mayor and as Local Liquor Control Commissioner shall have all the powers and duties provided to them him or her as directed by the Local Liquor Control Commissioner and the State Liquor Control Act, being ILCS Ch. 235, Act 5, §§ 1-1 et seq.

<u>Section 3:</u> The Troy Municipal Code, Title III Administration, Chapter 32: Officers, Employees and Other Workers, Section 32.126 (Reserved) shall be created to read as follows:

## § 32.126 FREEDOM OF INFORMATION ACT OFFICER.

- (A) There is hereby created the position of Freedom of Information Act (FOIA) Officer of the city.
- (B) The Mayor with the advice and consent of the corporate authorities shall appoint a FOIA Officer. The Mayor may appoint more than one FOIA Officer.
- (C) Appointments shall be annual appointments for one year from May 1 to April 30.
- (D) FOIA Officers shall receive a 75-cent hourly premium that will be added to the employee's base pay.

(E) FOIA Officers shall receive requests for information submitted to the eity under the Freedom of Information Act, being ILCS Ch. 5, Act 140, §§ 1 et seq.; ensure that the city responds to requests in a timely fashion; and issue responses under the Act.

<u>Section 4:</u> The Troy Municipal Code, Title III Administration, Chapter 38: Policies, Sections 38.001-38.007 shall be deleted in their entirety.

<u>Section 5:</u> If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.

<u>Section 6:</u> This Ordinance shall be in full force and effect from and after its passage and approval as provided by law and shall be published in pamphlet form by the authority of the City Council.
